### HOW TO SUBMIT AN ENTRY FORM

- 1. <u>Please be certain to use the correct Entry Form located in the back of this Livestock</u> <u>Guidebook.</u>
- 2. What to turn in:
  - Entry Form with Signatures
  - Applicable fees
  - Release & Wavier of Liability Agreement Form with Signatures
  - Large Animal Insurance Form (as needed)
  - YQCA Ethics certificate of completion (9 years and up) www.YQCAprogram.org
- Exhibitor, Parent/Guardian (if exhibitor is under 18) and Leaders/Advisors must sign the Entry Form.
  - 4. Entry Forms and fees may be mailed or delivered to the Fairground's Administration Office.
  - 5. Entries must be physically at the Fairground's Administration Office by 5 PM on the closing date. (No postmarks) <u>Email or faxed entries will not be accepted.</u>
  - 6. Entry Forms may be delivered to the Fairgrounds Administration Office between 8AM and 5PM, Monday through Friday. For your convenience, any after-hours deliveries may be left in the drop box.
  - 7. Incomplete forms and entries will not be accepted.
  - 8. The Fairground's Administration Office is located on Highway 49, two miles South of Angels Camp at 2465 Gun Club Rd., Angels Camp, CA 95222.

# LARGE ANIMAL ENTRY DEADLINE - April 5, 2025, BY 5PM SMALL ANIMAL ENTRY DEADLINE - April 18, 2025, 4PM

The 2025 state rules are not available at the time of this publication. However, if they become available by the 2025 Calaveras County Fair they will become the point of reference. Remember when referring to state rules; a local fair can be more restrictive than state rules but not more lenient.

# WHO CAN ENTER?

The Calaveras County Fair Junior Livestock Program is open to residents of Calaveras County only unless otherwise stated (horse show). In the event an out of county exhibitor wishes to participate in the Calaveras County Fair Show and Sale, he or she must first get approval from FFA, 4-H or Grange. After said approval, the 39<sup>th</sup> District Agricultural Association Fair Board of Directors will make the decision on a case-by-case basis. Independents are not eligible for an out of county waiver.

### **GENERAL DEFINITIONS:**

- Amateur A person who engages in an event or activity as a pastime rather than a profession. (Does not apply to junior organizations and horse shows.)
- Cash Awards Monies paid to successful contestants. (Synonymous with Premiums.)
- Class A group of like exhibits that are judged together, a subcategory of a division.
- Competition A contest between two or more exhibits.
- Division A generalized category of exhibits or a group of classes.
- Entry An object, project animal or collection of objects or animals intended for exhibit.
- Exhibit An entry becomes an exhibit when it is shown or judged at the fair.
- Stall Fees A fee charged to enter a competition. All stall fees shall be included with the proper forms on or before the competition deadline. (Synonymous with Entry Fee.)
- Exhibitor The owner of the animal.
- Junior Livestock Committee (JLC) A group of volunteers that facilitates the Junior Livestock Show and Sale.
- Judging Systems -

a. American - The judging process to rank exhibits against one another and award one first placing, one second, etc.

b. Danish - The judging process to compare each exhibit on its own merit against the scorecard or recognized standard and award as many first placings, etc. as merited.

- Junior Department A department provided for youth.
- Large Animals Beef, Sheep, Swine, Dairy Cattle, Dairy Goats (exception Nigerian Dwarf Goats), Boer Goats, Market & Fiber Goats, and Horses.
- Small Animals Poultry, Rabbits, Cavies, Pygmy Goats, Nigerian Dwarf Goats and Avian Species.
- Local Division A division or class open only to legal residents or producers in the county or district in which the fair is held.
- Entry Guidebook An entry book, prize list, contest book or other publication specifying rules and awards for Fair contests.
- Producer One who, in the area specified, raises in normal marketable or commercial quantities, the specific type of animal or product entered.
- Professional A person who engages in an event or activity as a livelihood rather than as a hobby. I.E. Fitter or Groomer.
- Senior Department Any department not considered a junior department.

# **JLC AUCTION DEFINITIONS:**

- Buyer One who purchases an animal at the Junor Livestock Auction.
- Seller An exhibitor participating in the Junior Livestock Auction.
- Declaration/Consignment for sale Form used for the exhibitor to declare an animal that is intended to be sold at the Junior Livestock Auction.
- Process & Return An animal purchased at the Junior Livestock Auction that is processed, sent to a cut and wrap facility for the buyer's personal use.
- Resale An animal purchased at the Junior Livestock Auction and is resold to a designated third party. The buyer pays the difference between the bid price and the amount the designated third party purchased the animal for.
- Live Pick Up An Animal purchased at the Junior Livestock Auction in which the buyer chooses to take said animal home.
- Boost An opportunity for individuals to add on to the purchase price of an animal that has been sold at the Junor Livestock Auction.

# LOCAL RULES:

- 1) All Large Animal (Beef, Swine, Sheep, Meat Goat, Dairy Goat, and Horse) Exhibitors will be required to pay a \$5 Large Animal Insurance Fee per family.
  - A "family" is a group consisting of parents/guardians and children living together in a household.
- 2) No Refunds.
- 3) All Fair-time exhibits <u>must be in place</u> by Wednesday, May 14<sup>th</sup>, 2025, per the listed schedule to be announced before Fair.
- 4) Market Poultry must be in place Tuesday May 13<sup>th</sup>, by 5 PM.
- 5) All classes, unless otherwise specified, are open to residents of CALAVERAS County only for the 2025 Fair.
- 6) Large Animal Entry Forms must be completed and turned in to the Fair Office by April 5, 2025, no later than 5:00 PM. Drop box available.
- 7) Small Animal Entry Forms must be completed and turned in to the Fair Office by April 18, 2025, no later than 4:00 PM. Drop Box available.
- 8) Late entries will be accepted until Friday, April 25<sup>th</sup>, 2025, at 4PM. LATE entry forms <u>must</u> be accompanied by a \$100 late fee <u>per class</u> and must physically be in the Fair Office by April 25<sup>th</sup> at 4PM. <u>No incomplete entries or forms will be</u> <u>accepted. No exceptions.</u>
- 9) Entry forms must have the signature of the exhibitor, parent/guardian (if exhibitor is a minor), and the community or project leader/advisor.
  - Be sure to print the name of leader on form.
- 10) By signing the entry form, exhibitors, parents, and leaders signify that they have read and are agreeing to abide by all local and state rules.
- 11) Cash premium awards will be given for large animal breeding projects, 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> places. \$10, \$8, and \$6, respectively.

- 12) Calaveras County Fair Junior Livestock disbursements for exhibitors participating in the Junior Livestock Auction will be distributed when the Calaveras County Fair has received adequate funds to facilitate payments <u>or</u> within 90 days of the Auction, whichever occurs first. The Fair does not make partial payments to exhibitors.
- 13) Management reserves the right to cancel entries, cash awards, and request the removal of exhibits from the grounds when exhibitors are disorderly, endangering or disturbing the public or other exhibitors. Non-Market ready animals are not sale eligible.
- 14) The management reserves the right to limit entries to two exhibits per class, if deemed necessary.
- 15) All reasonable care will be taken to prevent loss or damage to exhibits, but in no event will the Calaveras County Fair be held responsible for any injury or loss which may occur.
- 16) Independent Exhibitors must not have been in a junior organization with that project within 60 days (150 days for market beef project or 120 days for horse project) to be eligible to participate as an independent exhibitor.
- 17) Independent Exhibitors must file a form of intent by the appropriate ownership dates.
- 18) Non-Adherence to the rules: Any person found guilty of misrepresentation or not abiding by the rules in this book may be disqualified and denied the privilege of showing at the fair the following year or years.
- 19) The management shall reserve the right to vacate, declare ineligible for competition, and/or order the removal of any entry which is not in the best interest of the fair, is unsightly, unhealthy, injured, lame, unsound, endangers public safety, or has been entered in violation of these rules and regulations
- 20) Vehicles on the grounds or parked in unauthorized areas will be towed at the owner's expense.
- 21) Vehicle passes admit only the vehicle. Each occupant must have a ticket or wristband to be allowed on to the Fairgrounds.
- 22) Consumption by minors of any alcoholic beverages at any time while on the Fairgrounds is prohibited. It is the responsibility of the parents and chaperones of record to inform minors in their charge of this policy, and to assist security, law enforcement and fair management in its enforcement. Violations of this policy will cause disqualification of exhibits and/or prosecution of the minors and adults.
- 23) The use or possession of illegal substances of any kind, by anyone, is prohibited on the Fairgrounds. Violators of this policy are also subject to disqualification of exhibits and/or prosecution.

- 24) Exhibitors will not use abusive, questionable, or unethical techniques in the construction, preparation, presentation or handling of their exhibits. Exhibitors will not resort to fraudulent, deceptive or illegal practices when preparing exhibits.
- 25) All project leaders and/or independent exhibitor parents must attend the best practices seminar.
- 26) Exhibitors must provide bedding.
- 27) ALL livestock must be under the SOLE control of the exhibitor to and from the scales, and to and from the show ring, unless exhibitor has 2 animals in the same class.
- 28) All animals must be fed and watered by 9 AM daily. No wheelbarrows permitted in the barns after 9 AM until the conclusion of all shows (Thursday through Sunday)
- 29) No Automatic Waterers Permitted. Automatic waterers defined as "being directly connected to the Fair watering system."
- 30) Market Animals presenting a male testicle cannot be shown in a market class and cannot be moved to a breeding class.
- 31) Market Animals who are sifted at the scale by the veterinarian cannot be moved to a breeding class and must leave the fairgrounds.
- 32) There are no dogs permitted on Fair property. Exhibitors who bring dogs will be asked to leave and may forfeit the opportunity to weigh their animal.

#### PROTEST POLICY:

- 1. Protests will be considered only if there has been a violation of state or local rules. Decisions of judges, veterinarians, weigh masters, breed callers, tail dock officials and timers cannot be protested and are final.
- 2. All Protests must be accompanied by a deposit of \$500 (cash, money order or certified check made payable to Calaveras County Fair). Note: The deposit will be returned if the protest is upheld. If the protest is upheld, the violator may be held liable for any portion of the direct costs incurred by the fair during the protest resolution. Failure to reimburse the fair shall be cause for disallowing future entries in any of the network of California Fairs.
- 3. Given the short duration of the fair:
  - a. The protestor shall make every effort to file the protest prior to judging. All protests must be filed in writing within 24 hours of the time of the cause of the protest and before conclusion of fair.
  - b. The fair will make every effort to resolve protests as quickly as possible. All exhibitors, by entering an exhibit and all persons by filing a protest agree to cooperate with Fair Management to resolve protests in a timely manner.
  - c. Protests shall be adjudicated by Fair Management and/or members of Board of Directors.

- 4. Any exhibit involved in a filed protest before or during judging is eligible to compete until the protest is resolved.
- 5. Classes that involve a protested exhibit will not become official until the protest is resolved.
  - a. In Championship or special award classes that involve the protested exhibit the judge shall also select 1<sup>st</sup> and 2<sup>nd</sup> runners-up in case of disqualification.
  - b. In the case of protest, the unofficial judging results may be used to prepare the sale list and other necessary information.
- 6. At the discretion of the CEO judging can be delayed allowing time for the fair to resolve the protest if to do so does not unreasonably delay or disrupt the operations of the remainder of the fair judging and auction events.
- 7. Prior to judging the affected class, fairs may announce that an entry has been protested.
- 8. All questions concerning competition or non-protestable disputes or differences with staff or the exhibition not provided for under the State or Local Rules shall be referred to the CEO or their designee (designee will be assigned before the start of Fair), whose decision shall be final.
- 9. Violations of State Rules may be appealed to F&E in writing.
- 10. An individual may appeal to F&E only after adjudication at the local level and only if:
  - a. The decision upholds a Local Rule that circumvents or is not in the spirit of a State Rule(s).
  - b. The individual can substantiate new and credible information that was not available at the time of the local decision; or
  - c. There was inappropriate adjudication at the local level that may have included conflict of interest, lack of due process, or a significant misinterpretation of rules.
- 11. A Fair or State, national or international organization or subdivision thereof which has a significant stake in the interpretation of rules affecting the network of California fairs may make an appeal directly to F&E concerning multiple-fair issues, industry-wide issues, unavoidable conflict of interest or assistance in enforcing its own organization rules.
- 12. No protest will be accepted unless it:
  - a. Is filed or received, in writing, with a signed original and a signed duplicate copy.
  - b. Clearly states which rule has been violated.
  - c. States when the protestor first became aware of the facts and rule violation.
  - d. States the facts relied upon for the basis of the protest.
  - e. States that the protestor will cooperate with the investigation of the protest and that the protestor will be available and agrees to attend any hearing held to resolve the protest at the time and place directed by F&E.
  - f. Includes the names of supporting witnesses, with accessible phone numbers; and
  - g. Describes or attaches any document/s relating to the protest, which must include the written decision issued by the local arbitrating body.

- 13. The Fairs & Expositions Branch (F&E) must receive the appeal in writing within 24 hours from receipt of notice of local decision.
- 14. A hearing may be conducted at the discretion of F&E. The Director of F&E may consult with and/or request that members of the State Rules Advisory Committee participate in any hearing.
- 15. Once the Director has ruled on an appeal to F&E, no additional protest or appeal will be considered relating to that incident.



### **Ticket and Pass Information**

- Exhibitor wristbands available for pre-purchase on/before March 18, 2025
- Exhibitors are required to purchase admission passes (4-day wristbands available)
- Family members of exhibitors may also pre-purchase their admission passes
- The discounted exhibitor prices are extended to family members
- There are a limited number of exhibitor camping spaces (with 1 parking pass)
- Camping for Fair will be available <u>ONLINE ONLY</u> at 6 AM, January 2, 2025
- One (1) "Lot A" parking pass is available for purchase per family until sold out (LIMITED AMOUNT AVAILABLE)
- Discount admission, parking and carnival passes are available until Wednesday, May 14, 2025, OR UNTIL SOLD OUT (whichever comes first)



#### AGE REQUIREMENTS:

- To exhibit Market and Breeding Beef, Market Swine, Market and Breeding Sheep, Market, Breeding and Dairy Goats, Market Poultry, Market Turkey, Market Rabbit, Horses, Llamas and Alpacas: Exhibitor must be 9 years as of 12/31/24, and may exhibit until the calendar year in which he/she reaches age 19.
- For FFA members, an exhibitor may exhibit until the end of the calendar year following the year of graduation from high school.
- To exhibit Pygmy Goats, Nigerian Dwarf Goats, Cavies, Breeding Rabbits and Breeding Poultry; Exhibitor must be 5 years old by 12/31/24 and may exhibit until the calendar year in which he/she reaches age 19 unless otherwise stated.
- All Independent, Calaveras Grange and or Pony Club members who are ages 5 through 13 by 12/31/24, will compete in the 4-H/Grange Classes. The Exhibitors ages 14 through 19 by 12/31/24 will compete in the FFA/ Grange classes.

#### **UNIFORMS:**

- 1. FFA show uniform for boys and girls: White shirt with a blue FFA necktie, official jacket zipped to the top, white trousers/jeans, clean shoes or boots.
- 2. 4-H show uniform for boys: 4-H cap, white shirt, green 4-H tie, white pants or blue denim pants and clean shoes or boots.
- 3. 4-H show uniform for girls: 4-H cap, white blouse, green 4-H scarf with a plastic or metal ring to fasten; white pants or blue denim pants and clean shoes or boots.
- 4. Calaveras Grange show uniform for boys/girls: Collared white shirt and red vest with Grange emblem on back and blue denim jeans that are not faded, clean shoes or boots.
- 5. Independent Exhibitors: White or blue jeans and white shirt, clean shoes or boots.
- 6. An exhibitor who enters the show ring inappropriately dressed may be asked to leave the ring.
- 7. Rabbit, Cavy and Poultry Exhibitors must wear long sleeves.

### MANATORY BEST PRACTICES SEMINAR IS SCHEDULED FOR JANUARY 16, 2025, 6 PM

THE SEMINAR WILL BE HELD IN MARK TWAIN HALL AT THE CALAVERAS COUNTY FAIRGROUNDS.

Best practices are about developing program standards through constructive conversations regarding the most significant fair/livestock industry issues and ideas to create efficiencies and solutions. This presentation will include rule and policy review, proper feeding and housing guidelines, and leader/advisor and parent responsibilities at the fair. This presentation <u>is required</u> for all project leaders/advisors and parents of independent exhibitors.

# SCORE CARDS

The JLC and Fair Management hire quality judges. Score cards are used as a tool by judges. However, all judging is subjective. It is the judge's opinion that day.



#### BEEF:

- Market Ready Market Beef projected to have sufficient fat deposition to meet the marbling specifications for USDA "Prime," "Choice," or "Select+" quality grades
- Non-Market Ready Market Beef lacking evidence of sufficient fat deposition to produce a desirable consumer product. Beef projected to grade USDA "Select-" or lower.

#### SWINE:

- Market Ready U.S. No. 1 and No. 2 Hogs of average or greater conformation that are acceptable in leanness, muscularity and production traits.
- Non-Market Ready Any Hog of below average conformation including U.S. No. 3, U.S. No. 4 and utility grade hogs.

#### SHEEP:

- Market Ready USDA Prime or Choice quality with 12<sup>th</sup> rib back fat range of .16 to .35, average or grader conformation and cutability.
- Non-Market Ready Good or lower quality grade with 12<sup>th</sup> rib back fat range of <.16 or >.35; under finished lambs grading USDA good or lower, below average conformation or cutability.

#### GOATS:

- Market Ready USDA Prime or Choice quality with 12<sup>th</sup> rib back fat range of .08 to .12 most desirable, .13 to .22 back fat acceptable, average, or greater conformation and cutability.
- Non-Market Ready Good or lower quality grade with 12<sup>th</sup> rib back fat range of <.08 or >.22; under finished goats grading USDA good or lower, below average conformation or cutability.

## LIVESTOCK RULES

#### **GENERAL:**

- 1. 2024 State Rules for California Fairs are available at the Fairgrounds Administration Office. 2025 rules will be at the Fair office when available.
- 2. All livestock exhibitors age 9 or above on 12/31/24, must take the YQCA online Ethics Awareness Class to participate in the 2025 Calaveras County Fair & Jumping Frog Jubilee. (NOT REQUIRED FOR HORSE SHOW OR CAVIES)
- 3. Fair is open to primary member's ages 5 years old through 8 years of age (by 12/31/24), <u>exhibit only</u>. The use of Danish and American systems of judging is not acceptable for use with primary members; therefore, they receive recognition for participation only.
- 4. Primary (Mini) Members do not pay stall fees
- 5. Co-ops are permitted in rabbits, poultry and turkeys ONLY.
- 6. All animals shown at the fair <u>MUST</u> have current preventative vaccines. (Including but not limited to Erysipelas vaccine in swine)
- 7. All poultry and turkeys must be inspected before entering the Fairgrounds.
- 8. All sheep and goats are required to have a USDA approved Scrapie Identification. Included are Scrapie Flock Certification Program ear tags, legible registration tattoos if accompanied by registration papers or electronic identification.
- 9. Livestock pens will be assigned by the Livestock Superintendent and cannot be changed without their permission.
- 10. There will be designated areas for tack.
- 11. Barns are "species specific." After weigh-ins animals MUST be housed & fitted to the specie specific barn or designated area.
- 12. <u>A load-in schedule for large animals will be made available the first week of May.</u>
- 13. <u>Market Poultry must be in place by 5 PM on Tuesday, May 13th</u>.
- 14. <u>All non-poultry exhibits must be in place by Wednesday, May 14th per the schedule To</u> <u>Be Released before Fair</u>
- 15. If an Exhibitor is not bringing an animal to the Fair, they must notify the Livestock Office immediately of this scratch.
- 16. Permanent ID, ear tags, tattoos, leg bands, etc. will be assigned to Market Animals either at voluntary pre-fair weigh-ins, on Tuesday, May 13<sup>th</sup> or Wednesday May 14<sup>th</sup> before official weigh-ins.
- 17. All animals being weighed must have an ear tag/band/tattoo number prior to official weigh-in.
- 18. It is the responsibility of the Exhibitor to have their animals weighed at the designated times.
- 19. Exhibitors will not be allowed to wash animals during the official Fair weigh-ins.
- 20. All re-weighs must be performed immediately following the first weigh-in. If the animal leaves the scale area, a re-weigh will not be allowed. It is the responsibility of the exhibitor to receive their weight information immediately. Re-weighs will not be permitted for poultry, turkeys, rabbits, or cavies. Scales will be closed until official weigh-ins.
- 21. All animals must be completely dry at the official weigh-in.
- 22. Halters and blankets must be removed before any animal is put on scale for official weigh-in.
- 23. An animal entered in a market class that weighs less than the minimum weight for that division will be transferred to the appropriate feeder class. However, feeder animals will not be transferred to a market class if they are too heavy for their feeder division.

- 24. All market animal classes are limited to entries as follows: a 4-H, FFA, Calaveras Grange or Independent Exhibitor\_may enter unlimited market animal units (including meat chickens and rabbits); however, may not show more than four market units total and only two of the same market unit. Only four market units will be permitted on the Fairgrounds. All trailers will be inspected at the lower gate. No exceptions.
- 25. Muzzling of any animal is prohibited unless recommended by the Fair's official veterinarian.
- 26. Only those animals entered will be allowed on the Fairgrounds. Natural mothers (of offspring) of a not weaned entry will not be allowed on grounds, including parking lots and camping areas. No nurse cows.
- 27. Only animals eligible to be exhibited in a conformation class may remain on the Fairgrounds after weigh-ins.
- 28. A neck safety tie will be required on all cattle.
- 29. All Exhibitors are required to have stall cards for each livestock exhibit. The card shall have the following information: Exhibitor's name and club, breeder's name and location, name of the animal and breed type. Livestock Office has blanks.
- 30. If an exhibit is determined ineligible under State and/or Local Rules, during or after judging, the Exhibitor shall forfeit all awards and sale eligibility.
- 31. An exhibitor, parent, and leader/advisor barn curfew will be enforced from 10:00PM until 5:00 AM each day of the Fair. Animals diagnosed by the Fair veterinarian will be either sent home or moved to the isolation area. Parents, leaders and/or exhibitors will only be permitted to stay in the barn area after curfew if deemed necessary by the Fair vet. Additionally, a Fair employee or appointed volunteer must be present. Exhibitors violating the barn curfew may be removed from the show and/or auction.
- 32. Locks are prohibited on pens.
- 33. All pens must be cleaned before exhibitors leave the Fairgrounds on Monday, May 19<sup>th</sup> by their scheduled time. Violations of this policy will result in a \$25 fine per small animal pen and \$200 per large animal exhibitor. However, in the beef barn, the club and/or chapter will be fined.
- 34. A tear-down schedule will be provided for the removal of tack, stall cards and exhibits for Monday, May 19<sup>th</sup>, 2025. Violations of this policy will result in a \$25 fine per exhibitor. Market Animals not in the sale may be released Saturday, May 17<sup>th</sup> between 6 AM and 8 AM. A penalty will be assessed for any animal prematurely removed.
- 35. <u>All livestock Entry Forms including breeding exhibits must have Bill of Sale attached.</u> <u>Only animals in Co-ops may use a Bill of Sale from the club or chapter. Animals purchased by a club or chapter must have original ID numbers. Bred by Exhibitor, and Horses must have a written ownership statement by the exhibitor or parent.</u>
- 36. Grooming and fitting: The Fair is an educational experience and, as such, exhibitors must fit and groom their own animals for show. Exhibitors may receive <u>limited</u> assistance for instructional purposes from their parents, siblings, leaders and/or advisors. *No professional fitters*. <u>NOTE</u>: Violation of this rule as determined by the JLC will result in disqualification of the exhibitor and exhibit, forfeiting all awards, premiums, and eligibility to participate in the auction.

#### **OWNERSHIP INFORMATION**

The official ownership date is the date shown on the receipt of sale, unless the animal was bred by exhibitor. These days are counted prior to the opening day of Fair, unless the event is held separately from the Fair.

All exhibitors must have viable proof of ownership available to Fair and Livestock Officials at their request. Market animals (Beef, Sheep, Meat Goats, Swine, Rabbits and Poultry) must be owned and under exhibitor's daily care according to established rules and regulations for the fair.

The official Ownership date is the date shown on the bill of sale, unless the animal was bred by the exhibitor, in which case calving or birth records must be shown.

- a. Beef (150 days)
- b. Goats, Sheep, Swine, Turkeys, Rabbits, Cavies, All Breeding Projects including

poultry. (60 days)

- c. Market Poultry (39 days)
- d. Market Rabbits (30 days)
- e. Horse (120 days)
  - Horse projects may be leased.
  - Leased horses may not be shown for conformation in the halter classes.
  - Exhibitors must have the signature of the leader or advisor on the lease.
  - A copy of the lease and a photograph showing the side profile of the horse must be on file at the Fair office 120 days before the show.

### **INDEPENDENT EXHIBITORS**

1. All Independent Exhibitors (including horse) must provide the Fair Management with a photo of the exhibitor with his/her project. Picture must include exhibitor, animal and official Fair assigned ear tag.

\*\*Pictures are due to the Fair Entry Office by the appropriate species ownership date. \*\*

- 2. Independent Exhibitors must submit proof of attending a school in Calaveras County or a district transfer for the length of the project.
- Independent Exhibitors showing market animals must have the animals identified with an ear tag/band provided by the Fair. The ear tag number <u>must be visible</u> in the photograph.
- 4. Independent horse exhibitors must file lease information with the Fair entry office.
- 5. Independent exhibitors must keep a record book.
- 6. Parents of independent exhibitors must attend the "Best Practices Seminar".
- 7. Independent exhibitors will be judged as a group for Herdsman.

# LIVESTOCK CODE OF ETHICS

\*\*\* The Calaveras County Fair requires <u>all exhibitors</u> to participate in the YQCA online Ethics Awareness Class. \*\*\* (Mini Members are exempt)

- Junior training must be completed yearly
- Intermediate exhibitor may challenge the course for a 3-year exemption
- Senior exhibitors may challenge the course for a 3-year exemption
- A copy of completion or exemption must be presented with entries EVERY YEAR

Mandatory - The State of California has adopted the following program:

# JUNIOR LIVESTOCK AUCTION

The Junior Livestock Auction is an amazing program where young producers can market their animals. The program is the focus of several community volunteers who work diligently to make this opportunity a reality for the youth of the community.

- 1. Open to market animals exhibited and judged in a Junior Livestock Class at the Calaveras County Fair.
- 2. Exhibitor must be a resident of Calaveras County in order to sell at the Junior Livestock Auction.
- 3. Project Record Books, including those of Independent Exhibitors, must accompany the livestock consigned for sale to the Fairgrounds and be available for review by the Junior Livestock Committee at any time during the Fair.
- 4. Animals will be identified by an official identification ear tag, tattoo, or leg band as approved by the Junior Livestock Committee.
- Exhibitors and their leader/instructor are responsible for tagging, tattooing, or banding their animals. If assistance is needed in doing so, a member of the Junior Livestock Committee will help.
- 6. The selection of meat pens shall be made prior to the official Fair weigh-in. Identification numbers will be assigned by the Fair entry office, and it is the exhibitor's responsibility to contact the Fair for their number(s).
- 7. Exhibitor may show four (4) market units.
- 8. <u>All FFA/Grange and 4-H Grange Champions</u> must sell in the Junior Livestock Auction except animals in the Donation Animal Program.
- 9. All exhibitors may sell <u>one large</u> market unit and <u>one small</u> market unit at the Junior Livestock Auction.
- 10. A Large Market Unit is as follows: Market Beef, Market Lamb, Market Swine, Market Goat,
- 11. A Small Market Unit is as follows: Pen of Meat Chickens, Pen of Meat Rabbits, Single Broiler Chicken, Single Fryer Rabbit and Single Market Turkey.
- 12. All exhibitors must inform the Livestock Office which animal he/she will be selling within two hours of the Exhibitor's final conformation class. If an Exhibitor has two units of the same species eligible for sale, he/she must inform the Livestock Office of the "no sale animal" within two hours after the completion of the final conformation class for that species. In the event the exhibitor fails to notify the

livestock office within the designated time. The exhibitor will be dropped from the sale order. Exhibitor must pay a \$75 reinstatement fee (cash only) by Friday, May 16<sup>th</sup> at 7 PM to be reinstated into the sale.

- 13. Actual weight at the time of the official weigh-in will be used for sale and judging weights of all species. Weight slips will be issued and attested by a fair representative.
- 14. The sale order will have a Supreme Champion, Reserve Supreme Champion, FFA/Grange Champion, FFA/Grange Reserve Champion, 4-H/Grange Champion, and 4-H/Grange Reserve Champion in each of the nine animal units. These Sale Champions shall be selected from the top two Market Ready eligible units from each class in each category by the official junior livestock fair judge.
- 15. Bank of Stockton and the Fair Management will handle all financial matters between buyers and consigners.
- 16. Calaveras County Fair Junior Livestock disbursements for exhibitors participating in the Junior Livestock Auction will be distributed when the Calaveras County Fair has received adequate funds to facilitate payments <u>or</u> within 90 days of the Auction, whichever occurs first. The Fair does not make partial payments to exhibitors.
- 17. Six percent of the gross sale price of each animal will be withheld to defray auction costs.
- 18. Animals consigned for sale and sold are not eligible for re-purchase from the sale committee. Responsibility and care for livestock sold at the auction remains with the exhibitor until the animal is harvested.
- 19. All poultry are terminal, no exceptions.
- 20. The seller will be responsible for complete restitution in dollar value if the specific animal purchased is not available for delivery at the close of the fair.
- 21. There will be <u>no</u> needles, syringes, medications including, but not limited to: approved, extra label use or over the counter drugs allowed on the fairgrounds. Any medication must be administered by the Fair's official veterinarian or under their direction.
- 22. Sale weight will be the maximum weight for that class as listed in the Livestock Guidebook.
- 23. Any Exhibitor who is unable to sell his/her animal and has not made prior arrangements with the Junior Livestock Auction Committee President by 9:00 AM on the day of the auction to have someone else sell his/her animal, will receive only resale price for their animal.
- 24. All animals must have their ear tags when they are loaded on the truck. If an animal does not have its ear tag, it will not be loaded.
- 25. Auction animals that are declared unfit at the process house will become the full financial responsibility of the seller.

- 26. Processed Market Poultry or Turkeys, not picked up by the buyer within two weeks of the auction, will be donated to charity. Poultry and Turkey Exhibitors are encouraged to deliver items to their buyers.
- 27. In the event a market animal dies or is shipped incorrectly prior to the auction, an Exhibitor may substitute another animal of the same species that is eligible for the auction. The said animal must belong to the exhibitor. The Exhibitor will rotate to the end of the sale order within that species.
- 28. In the event an animal dies, the committee will reimburse the buyer at the current market price as determined by the appropriate processing plant at the time of the Junior Livestock Auction based on resale price.
- 29. Ear tags for non-independent exhibitors will be distributed at the Fair or at Beef weigh-ins.
- 30. The Calaveras County Fair has up to 90 days to pay exhibitors who participate in the Junior Livestock Auction.

#### DRUG STATEMENT:

- 1. Owner acknowledges the Federal Food, Drug and Cosmetic Act prohibits the introduction or delivery of any food that is adulterated or misbranded. Adulteration includes poisonous or deleterious substances, and new animal drugs defined as unsafe within the meaning of Section 512 (21 USC Section 260b) of that act and those drugs listed in Section 404 (21 USC Section 342).
- 2. Owner is responsible for animals that are rejected at processing center due to the presence of drug residues.
- 3. <u>WHOLESOME MEAT ACT</u>: The U.S.D.A. Wholesome Meat Act applies to all market animals. Only market animals eligible for <u>immediate</u> slaughter may be brought onto the fairgrounds and exhibited.
  - Animals must be in good health and free of drug or chemical residues.
  - Drug labels must be observed. Please note that elimination time (the time it takes for NO drug residue to be found in the animal's system) is longer than labeled withdrawal time for most approved drugs.
- 4. In the event drug testing is deemed necessary by Fair Board of Directors or the Fair's Vet; it shall be conducted as outlined by California Department of Food & Ag and/or the representative from the University of California Davis.

# Swine Projects at the Calaveras County Fair

## Junior Livestock Show & Sale

Background: Effective September 1, 2022, Animal Confinement regulations outline a regulatory framework of certification, registration, accreditation, and inspection for ACP to implement Health and Safety Code (HSC) sections 25990-25994, which was passed by California voters as the Proposition 12 initiative 2018. Implementation of this law was delayed due to litigation. In 2024 Producers must comply if they are producing a product that will be part of the California Food Chain.

- All exhibitors will be required to submit a copy of the Animal Care Program Certificate/Card at entry deadline, April 5, 2025.
  - <u>Animal Care Program Certificate</u>: A document that certifies the farm is in compliance with the ACP.
- Any producer, young or old, large, or small farms, 1 pig or 1000, must be inspected and certified. <u>There are no exceptions or waivers</u>. This includes Bred by Exhibitor animals.
- Breeder's self-certification is no longer permitted by law.
- The California Department of Food and Agriculture will provide FREE inspections and certifications <u>upon request</u>. For more information visit, https://www.cdfa.ca.gov/AHFSS/AnimalCare
- There is a list of private Certifying Agents on the CDFA website.
- Prior to purchasing project animals, exhibitors should verify their breeder has an Animal Care Program Certification.
- Projects without proper documentation will not be allowed to participate.
- <u>Although this law only applies to animals that are being sold for resale,</u> <u>ALL swine projects must comply.</u>

- k. The judge may disqualify any animal that is not sufficiently gentled to be shown safely.
- I. The judge may choose not to make any awards to any animal which shows visible evidence of disease or lameness. No award will be made to entries eliminated under this rule. All animals in the Horse Show must be serviceably sound.
- m. Juniors will be defined as between 9 and 13 years of age as of December 31, 2024. Seniors will be defined as 14 years or older, but under age 19 as of December 31, 2024. Pony division exhibitors are based on the height of the animal (14 hands, two inches or under) rather than the age of the exhibitor. It will be left to the judge's discretion if an exhibitor is too large for their pony. If so, exhibitor will be disqualified from competing.
- n. Walk/Trot exhibitors are based on the performance limitations (no cantering/loping) of the horse/pony. An exhibitor can only compete in the walk/trot division for a maximum of 3 years and not with the same horse/rider combination.

### **Donated Project Information**

**Background:** Over the last several years more than \$100,000 has been raised through the donated animal program. The Junior Livestock Committee has been able to remodel the livestock office, fix and roof the beef wash racks. Purchase sheep, goat, swine panels, scales and sound system. They have also been able to seal the beef, swine, and goat barns; as well as resurface and grade the Tower Pavilion and build a covered swine show ring.

Process: Local breeders donate a market animal. The breeder selects an exhibitor to raise the animal. The exhibitors donate their time and energy to ensure the animal meets all standards consistent with a market ready animal. The exhibitor may show the animal in market classes. The Junior Livestock Committee pays for the feed for the project. The project is judged at the fair and sold at the end of each species at the Junior Livestock Auction. The breeder and exhibitor do not benefit financially.

Specifics:

- 1. Exhibitors must turn in the Donation Project Contract by the entry deadline as described in the Junior Livestock Entry Guidebook.
- 2. The donated animal projects will be sold at the end of each species.
- 3. Only animals that have been predetermined will be part of the auction. No additional animals will be permitted.
- 4. A judge will inspect the projects to ensure the animals are Market Ready.
- 5. The exhibitor is expected to care for the project during the Fair and Junior Livestock Auction.
- 6. Raising a donated animal does not prevent an exhibit from participating in other competitions as outlined in Livestock Entry Guidebook.
- 7. The said projects will be tagged by the Junior Livestock Committee.
- 8. Raising a donated animal does not prevent the exhibitor from participating in the Junior Livestock Auction with a personal project.
