### **COMMERCIAL VENDOR APPLICATION INFORMATION**

**The Calaveras County Fair will be held May 16-19, 2024**

Thank you for your interest in being a commercial vendor at the Calaveras County Fair.

A **\$25 Application Fee** that is to be sent in with your application. This application is neither an offer nor a guarantee of space. **Outdoor booth fees** are \$550 for 10'x10' location, \$900 for 10'x20' location. **Indoor booth fees** are \$700 per 10' x 10', \$1,100 for a 10'x20' location for the duration of the Fair. **Indoor 8' Craft Table is \$300. Outdoor 8' Craft Table is \$200. Food Concessions is \$500 against 25% of daily receipts, whichever is greater.**

We are offering "**Craft**" **Vendors booths**. To be eligible, items must be handmade (no commercial products eligible). Limited spaces available. Note: the indoor building is locked every night and unlocked in the morning with supervision.

Indoor and Outdoor commercial booth fees include eight – 1-day admission passes and one – 4-day parking. Additional vendor admission passes are available at the reduced rate of \$6 per person per day and vendor parking passes are available for \$3 per day or \$12 for a 4-day parking pass for the duration of The Fair.

RV parking spaces are limited, so please contact us to reserve a space. The full hook-up sites are \$350 per site for the duration of the Fair, which includes two vehicle passes. Dry (non-hookup) campsites are \$100 for the duration of the Fair. **Stock truck parking \$100, with power \$200.**

*Tents, tables, and chairs are the responsibility of the applicant. All tents must be inherently fire resistive or treated and labeled accordingly. Equipment is not provided.*

**ALL VENDORS MUST PROVIDE INSURANCE** – A minimum of **\$1,000,000** general liability per occurrence, naming the Calaveras County Fair as additional insured. If a Vendor can not provide their own, insurance for this event, it may be purchased through California Fairs Services Authority (CFSA) which the Fair office will assist with this application.

**Fair hours:** Thursday and Sunday: 8AM to 11PM; Friday and Saturday: 8AM to midnight.

**BOOTHS MUST BE staffed for the following hours for the optimum selling advantage:**

Indoor Booths: Duration of the Fair – 10AM to 10PM

Outdoor Booths: Duration of the Fair – 10AM to 10PM

**There is a 20% discount for vendors who reside in Calaveras County.** Electricity, within limitations, is available for each booth. If you have excessive electrical needs, please contact the Fair Office prior to submission of this Application.
