CALAVERAS COUNTY FAIR & JUMPING FROG JUBILEE



ENTRY INFORMATION:

Entry Fee: \$125. Prize: 1st place – Buckle & \$100 Cash per Division.

Entry Limit: Each division will be limited to 10 contestants. One entry/person.

Entry Age: Contestant must be at least 16 years old as of January 1, 2024.

Entry Deadline: Entry Forms, Liability Waivers and Fees due May 11, 2024.

Quads: One Ranch/Stock Quad (Div. A) and One Race/Modified Quad (Div. B) will be provided. Contestants will NOT bring their personal quads.

NO ALCOHOL IN THE PIT AREA/ARENA. CONTESTANTS WHO APPEAR TO BE UNDER THE INFLUENCE OF ALCOHOL OR DRUGS WILL NOT BE ALLOWED TO PARTICIPATE.

OFFICIAL RULES:

- Each contestant will make a total of four runs, one practice run (non-official time), and three officially timed runs. The fastest 2 out of the 3 runs will be combined for a final time for each contestant. (Judges and arena staff will reduce the number of runs should we run into time constraints.)
- Should a contestant be disqualified by the judges, entry fees will not be refunded.
- A DOT approved helmet is required and must be worn for the duration of each contestants run. Eye protection is suggested but not required. Goggles/Glasses
- Over the ankle leather boots are suggested (no tennis shoes or open toed sandals allowed). Full length pants and a shirt are required (No tank tops).
- Arena may be worked up during the event.
- All contestants MUST attend the contestant meeting before the race. Frogtown Arena (Oak Tree) at 5:00pm.
- Unsportsmanlike conduct will not be tolerated. Any display of unacceptable behavior, decided by the judges, will result in disqualification. Should the conduct continue, contestant may be escorted off the premises.
- Judge/Flagman will start/stop the timing officials with a drop of the flag.
- Operator must stay on the quad during the run. Dismounting from the quad or losing control of the quad will result in a no time for that run.
- The standard clover leaf barrel pattern will be navigated. Option 1: Run one right turn, then two left turns around the barrels. Option 2: Run one left turn, then two right turns around the barrels.
- A 5 second penalty will be applied for each barrel that is knocked down. Any course corrections will result in a 10 second penalty. The judges decision is final.
- The judges will review all scenarios not covered by the official rules and their decision will be final.
