Official Rules

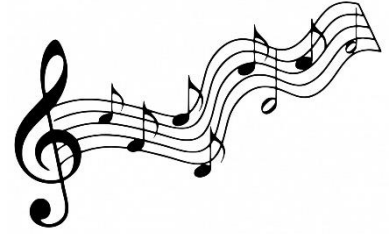
Calaveras County Fair & Jumping Frog Jubilee May 15-18, 2025

1. Contestants must live within Calaveras County. Proof of residency required.
2. Competition is for vocalists only.
3. Contestants may sing a cappella or to professionally recorded soundtracks, which the contestant must supply on a CD or thumb drive. Lead vocals on the track must have been removed. Contestant may accompany themselves instrumentally. No props, prompters or note cards may be used.

4. Music must be appropriate for audiences of all ages and may not include foul, gang-related, substance or alcohol abuse, racial, or discriminatory language, or sexual innuendoes, etc.
5. Contestant must sing one (1) song of their choice. Minimum of two (2) minutes, but not to exceed a total of four (4) minutes. Overtime of any amount will result in disqualification.
6. Contestant must sign and place on file with the Calaveras County Fair a "Release & Waiver Form" (attached) prior to the performance. Minors under the age of 18 as of the day of the competition must have the form also signed by a parent.
7. The Calaveras County Fair will accept the first 10 completed contestant forms with the \$15.00 entry fee. **The deadline is May 1, 2025.** Contestants will receive a 4-day pass to the Fair and a parking pass.
8. Contestants will be judged on vocal talent, stage presence and entertainment appeal. At the judges' discretion contestants may be asked to sing a second song.
9. **The competition will be held 2pm on Friday, May 16, 2025, on the Lawn Stage.**
10. The competition will be judged by a panel of 3 or more. All decisions of the judges are final. Contestants will be scored from 1 - 30. Points will be awarded in the following three areas, with up to 10 points in each area---vocal talent, stage presence and entertainment appeal.
11. The winner of the competition will win a trophy and \$100 cash prize.
12. Winner must be available to sing at 7:45pm on the Main Stage to open for the concert!
